Applicant Criteria:

 Applicant must have 3+ years of lived experience as a parent or in a parenting role raising a child/youth with emotional, developmental, behavioral, substance use or mental health concerns (parents or a caregiver/foster parent, or grandparent who has 3 or more years' experience raising that one child with mental health concerns);
Is also able and willing to articulate their lived experiences and

3. Applicant has 3+ years of experience navigating the systems of care such as children's behavioral health, child welfare, special education or juvenile justice system on behalf of that child. (Note: # of years of lived experience is determined from the date your child/youth received their first mental health diagnosis to today's date and is not from time of their birth. In the case of caregivers, foster parents or grandparents it would be from date the child came to live with you to todays date)

Training Includes: 2 hours of parent peer training in each of the 11 required Domain Areas as required by Maine and set forth the National Certification Commission for Family Support <u>www.ffcmh.org</u> (22+ hours plus 2 hours of discussion and activities = 24 hours total. Each graduate is certified as a "BHH parent/family peer specialist" as is required for Maine Behavioral Health Homes certification.

Parent/Family Peer Specialists have both Maine and National certifications and are available to help you meet the requirements of having BHH Parent/Family Peer Support!

Since its inception, family involvement has been a core value of systems of care and a core component of family involvement is the ability for parents and caregivers with lived experience and experience navigating services and systems to help other parents (e.g., parent-to-parent peer support).
