for Family Peer Specialists

**Applicant is vetted and they fully meet the following criteria:**

1. Applicant has minimum of **3+ years** of lived experience in parenting or in a parenting role (meaning biological parent, caregiver, foster parent or grandparent) with at least one child/youth whom lived with you for 3 or more years who has emotional, developmental, behavioral, substance use or mental health concerns.
2. Applicant is able and willing to articulate their lived experiences with that child/youth AND
3. Applicant additionally has **3+ years** of lived experience with that one child/youth in navigating some or all of the child serving systems of care such as children's behavioral health, child welfare, special education or juvenile justice on behalf of that child. (Note: both the # of years of lived experience and navigating SOC is determined/calculated from the date your when child/youth received their first mental health diagnosis to today's date. It is not calculated from time of their birth. In the case of caregivers, foster parents or grandparents it would be from date the child/youth came to live with you to today's date if still living with you or the date they left placement)

**Training Includes:** PPLI curriculum binder with tools and resource materials. Two hours in each of the 11 Domain Areas (required by Maine and set forth by the National Certification Commission for Family Support for Family Peer Specialists). Graduates receive certificates certifying as "Family Peer Specialists" as is required for employment in Maine Behavioral Health Homes. In accordance with the Code of Ethics for Family Peer Specialists they need to continue their education to have current general areas of knowledge that are in compliance with laws and regulations, duty to persons served and duties to the profession and will abide by the standards of practice.

Family Peer Specialists have both Maine and National certifications and are available to help you meet the State BHH requirements of having this family peer support specialist role for short term or long term!
